Contenedor metálico para uso interior de un residuo.

Dispone de cubeta interior en hierro galvanizado para facilitar el vaciado. Mediante la apertura de la tapa superior abatible, fabricada en chapa de hierro pintada en epoxy, color RAL a determinar, se accede a la cubetas interior, mediante dos bisagras de retención.

En la parte inferior del orificio de la tapa superior, se incorpora un elemento cónico fabricado en aluminio, que facilitará la auto-extinción de un fortuito incendio en su interior (ver Certificado de Ensayo de Ignifuguidad).

El cuerpo principal fabricado en chapa de hierro y acabado en pintura epoxy color RAL a determinar. Incluye 4 topes de goma para la protección de la superficie donde se ubique.

La tapa superior incorpora vinilo en el orificio para indicar el tipo de residuo.

Medida: 262 x 310 x 743 mm.

Capacidad: 40 Litros

Mantenimiento Funcional:

No requiere mantenimiento funcional. Limpieza recomendada con producto neutro y trapo húmedo.

Resistencia al fuego:

Por las características de sus materiales totalmente metálicos, el contenedor se puede clasificar como V0. (ver Certificado Ensayo Ignifuguidad)








At the end of the test, it was observed that:

In container nº 1, the paper was consumed almost completely.

In container nº 2, industrial thick cardboard hardly burned.

In container nº 3, plastic bottles and plastic films were not entirely consumed.

In container nº 4, thin cardboard and paper were consumed almost entirely.

In container nº 5, industrial plastic was consumed practically entirely.

Taking into account the results obtained, it is concluded:
